TERMS AND CONDITIONS

BOOKINGS

Bookings are from Friday to Friday for weekly breaks. Short breaks run from Thursday, Friday or Saturday depending on availability. ALL bookings are from 3.00 p.m. on day of arrival until 10.00 a.m. on day of departure. The total number of people staying in the barn must not exceed that stated on the booking form. Bookings will not be accepted from anyone under the age of 18, also there is a NO SMOKING policy in the barn.

DEPOSIT

If the booking is made over 6 weeks prior to the holiday commencing, then one third of the total cost must be paid. If the booking is made under 6 weeks prior to commencement of the holiday then the full amount is due. The balance of payment must be made 6 weeks before the start of the holiday – NON PAYMENT will result in loss of deposit and cancellation of the booking. Overseas applicants may pay by sterling cheque drawn on a UK bank.

CHANGING A BOOKING

Once a booking has been made it may be changed to another week, providing the barn is available on the date required. There must be at least 6 weeks notice given to change a booking.

CANCELLATIONS

All cancellations must be notified in writing within 7 days of the event causing the cancellation. Deposits will only be returned in the event of death, serious injury or illness or jury service. Holiday Cancellation Insurance is advised.

METHOD OF PAYMENT

Payments must be made by cheque or postal order made payable to **MRS. E. M. WELDHEN**, post dated cheques are not acceptable.

BREAKAGES AND DAMAGE

A damage deposit of £50 is required when making booking. All damages to accommodation, fixtures and contents is chargeable and must be reported, excessive cleaning is also chargeable. Damage deposit will be refunded by cheque within 2 weeks of your departure date less any charges deemed appropriate.

FACILITIES, TOWELS AND LINEN

Electricity, gas, bed linen, towels and tea towels are included in the tariff but please remember to bring your OWN beach towels and baby linen.

PETS

One small dog is welcomed but is not allowed in the bedrooms. The owners have full responsibility for any damage caused and are also asked to clean up after their dog.

OTHER

For the purpose of maintenance or in an emergency, the management reserve the right to enter the property at any time.

If due to any occurrence beyond our control the accommodation is not available as booked (eg. fire or flood), all monies will be refunded in full but there will be no further liability towards the hirer.
